




#### **POWER OF COMPOUNDING**

Programme covered following aspects:


- Understanding mutual fund, their advantages, types.

#### In the second session


The final speaker MS. Nishi Shabana (founder Lume Legal) gave insights into trademark intellectual property right procedure and process.

This is leading to the holistic development of the students in terms of personal growth and their academic growth.








#### **ABHIVYAKTI**
