Note:

1. Students shall opt for **Major Elective** papers from the same stream throughout all the semesters. For eg., if a student opts for a paper in the Ancient History stream in semester I, he/she will have to opt for papers in the Ancient History stream for semesters II, III and IV.
2. Students have to take any one of the two **Minor Elective** papers in semesters I and II.
3. Students have to take one **Open Elective** paper from **any other** Stream / subject / department in semesters III and IV.
4. The Elective Papers for students will be offered by the departments of the respective colleges on the basis of available resources and faculty strength there.
5. Students can write their individual examination papers in English or Hindi medium, but not in both.
6. Examinations shall be conducted at the end of each Semester as per the Academic Calendar notified by the University.
7. The system of evaluation shall be as follows:
  - (i) Each paper will carry 100 marks, of which 30 marks shall be reserved for internal assessment as determined by the faculty members teaching the respective papers.
  - (ii) The remaining 70 marks in each paper shall be allotted for a written examination to be conducted by the University at the end of each semester.
